3. Application along with requisite fee should be submitted through the Head of Institution.
4. **Candidate can be applied for review for maximum 3 (three) subjects of his/ her choice.**
5. The application Form & Fees along with all other relevant papers shall have to be submitted to the School and to the Board as per the time schedule given below:-
