- 4. Bidder should submit up to date Pan Card/ GST certificate/ Acceptance letter of the terms and conditions/ Bank account details/ Authorisation Certificate and approved rate chart of the company along with the tender.
- 5. No deviation from the stipulated terms and conditions will be allowed. Tenders should be unconditional.
