**NOTICE INVITING TENDER FOR SALE OF OLD PAPER.**

Sealed Tender on Plain Paper is hereby invited from the bonafied interested Buyers for purchases of old Answer Scripts, Loose sheets ,Forms ,Envelops etc. **"As is Where is Basis"** lying in the damping Room of Tripura Board of Secondary Education, Gurkhabsti, Agartala, West Tripura with following terms and conditions.

**The Terms of Reference of this Tender are as follows: -**

1) The validity of terms and condition of the Notice inviting Tender should remain valid up to 30<sup>th</sup> November 2020 and the successful buyer shall bound to purchase the Papers as per his/her quoted rate during the said period and in no circumstances rate cannot be changed for any purpose and for any reason whatever.

2) The successful buyer shall bound to complete the lifting of entire quantity of the Papers lying in the damping Room of Tripura Board of Secondary Education, Gurkhabsti, Agartala within fifteen days from the date of receipt of the Work Order.

3) **The last date for submission of tender is 12<sup>th</sup> October' 2020 up to 5 pm** and no tender will be received after the stipulated date and time. **The same will be opened on 13<sup>th</sup> Oct'2020 at 4 PM , if possible.** The tenderers or their single authorized representative may remain present at the time of opening of tender. If last day of receiving tender or the day of tender opening becomes paralysed due to any un-foreseen reason(s) / holiday then the next Govt. Working day will be the last day of receiving tender or the day of tender opening.

4) The Waste Papers will be sold and delivered on **"AS IS WHERE IS BASIS"**. Interested tenderers may visit the Tripura Board of Secondary Education, Gurkhabsti, Agartala on any working day during office hours to inspect the items and himself be satisfied about the quantity, quality after verification of the items. **No complain regarding the quality, quantity etc. will be entertained at any circumstances.**

6) All tenderers shall be accompanied with **Rs: 10,000/- (Rupees ten thousand)** only in the shape of **"Deposit At Call"/Demand Draft** from any Nationalized Bank drawn **in favour of "Secretary, Tripura Board of Secondary Education, Agartala"** as Earnest Money and without such Earnest Money no tender will be considered as valid and therefore out rightly will be rejected. The Earnest Money shall be returned to the respective tenderers except successful tender after finalization of the tender. In case of successful tenderer the amount will be treated as SECURITY DEPOSIT and which will be refunded only on satisfactory removal of the items.

7) The actual weight of the Waste Papers can be determined during dispose of the above items and the successful tenderer shall lift the entire quantity within 10 (Ten) days from the date of receipt of the lifting order in every case and should not be left a single piece of Waste Papers. In case of failure the lifting order shall be treated as cancel and the Security Deposit shall also be forfeited automatically.

8) The lifting of Waste Papers will be made under the supervision of a Committee to be constituted for the purpose.

9) The successful tenderer shall have to deposit the entire value of the items in advance through **Bank Draft in favour of Secretary, Tripura Board of Secondary Education**; Agartala before taking delivery and only after receiving the Draft the Waste Papers will be released.

10) No dragging, lifting, storage etc. facilities will be provided to the successful tenderer and such work are to be arranged by the tenderer himself.

11) The Earnest Money will also to be forfeited for violation of any terms and condition laid down in this tender notice.

12) Rate should be quoted Per Kg basis. Highest rate quoted will be considered for acceptance.

13) The tenderer should submit his photo Identity Card and mention the address in details even quoted the telephone number also. No conditional tender offered will be accepted.
